Counsel for all parties **must consult** with each other regarding the anticipated length of trial and number of witnesses, the need for a court reporter, and any other pertinent scheduling considerations or particular courtroom requirements. Plaintiff's counsel **must report** on such matters to Michael D'Antignac, Staff Attorney, by email at Michael.DAntignac@fultoncountyga.gov (copying counsel for all parties) or by phone at 404-613-0491 by **4:00 pm on November 16, 2012**. In cases involving a pro se plaintiff, the pro se plaintiff and defendant's counsel must report.

THERE WILL BE NO CONTINUANCES FROM THIS CALENDAR, EXCEPT FOR LEGAL CAUSE. ONLY JUDGE EDLEIN CAN CONTINUE A CASE FROM THIS CALENDAR. All requests for continuances must be in writing.

There will not be a CIVIL JURY calendar call. Counsel in the first case to be tried will be notified by the Court. CASES WILL NOT NECESSARILY BE TRIED IN THE ORDER THEY ARE PUBLISHED.

This is a **Continuing Calendar** and all cases will be on call for the entire calendar, subject to two-hour notice. All cases that are not reached on this calendar will be carried over to the next calendar and any subsequent calendar until they are reached for trial.

A consolidated pre-trial order(if required)and any motions in limine should be submitted no later than **November 19, 2012**, unless otherwise instructed by the Court. When the case is called for trial, counsel shall be prepared to submit proposed jury instructions in hard copy and electronic format. If a jury trial has not been requested, a consolidated pre-trial order and proposed jury instructions are not required.
